INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The Philippine Sports Commission, through its Bids & Awards Committee, invites interested eligible & accredited supplier/manufacturer/service providers to apply for eligibility and to bid as follows:

Prospective bidders shall possess a similar contract with value of fifty percent (50%) of the Approved Budget for Contract (ABC). Bidding shall be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".

A complete set of Bidding Documents may be purchased by Interested Bidders upon payment of non-refundable bid fee as stated above to the Cashier's Office located at the 2nd Floor, Administration Building, RMSC, P. Ocampo Sr. Street Malate, Manila during business days from 8:00 a.m. to 5:00 p.m.

The Philippine Sports Commission will hold a Pre-Bid Conference at the BAC Bidding Room located at the Ground Floor of the Administrative Building, Rizal Memorial Sports Complex, P. Ocampo Sr. St., Malate, Manila. Bids must be delivered to the address above. All bids must be accompanied by a bid security in any of the acceptable forms in the amount stated in the ITB Clause.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address above. Late bids shall not be accepted.

The Commission reserves the right to reject any and all bids, declare a failure of bidding or not to award the contract on the following ground:

- There is prima facie evidence of collusion;
- The BAC failed to follow prescribed bidding procedures;
- There is/are justifiable ground/s where the contract will not redound to the benefit of the government without incurring any liability to the affected bidder/s.
